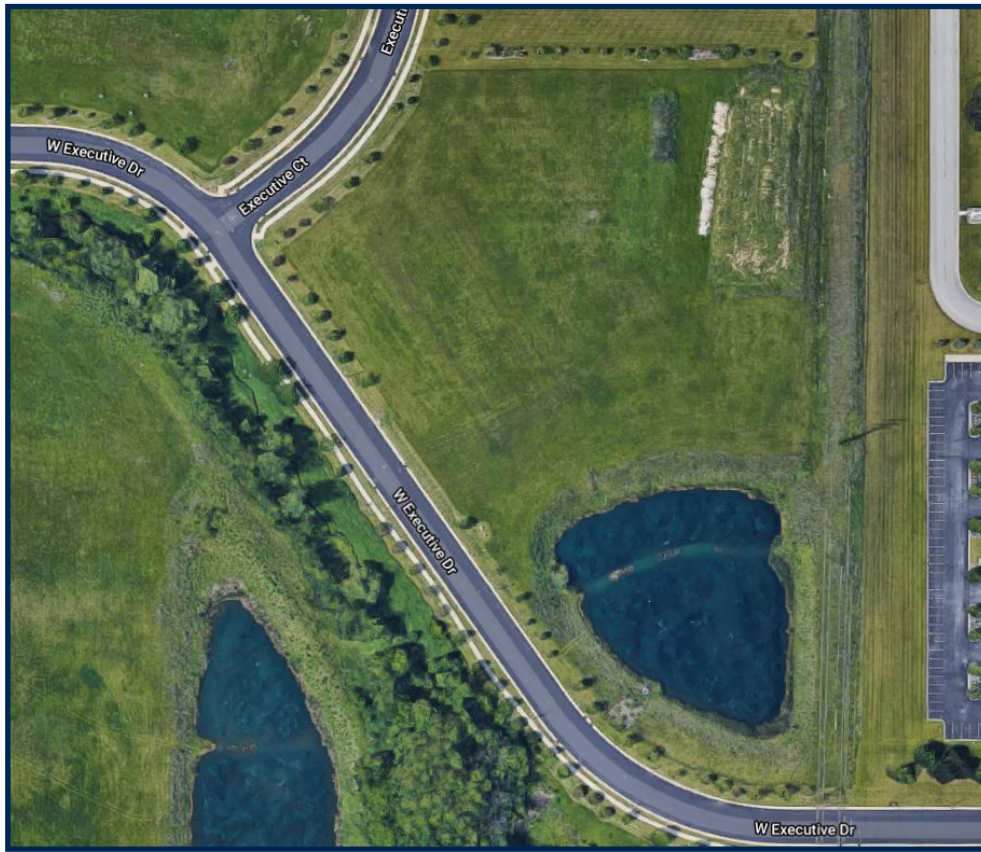

Disclosure to Non-Residential Customers
